**Determining the Validity Period of the Certified Copies of the Birth, Marriage and Death Registers.**

Since some institutes have imposed a validity period (ex.- that the certificate is valid only for a period of 06 months from the day of issuance) to the Certified Copies of the Birth, Marriage and Death Registers issued by the Registrar General, it has been observed that, there is a great tendency of the Public to obtain certified copies.

02. Accordingly, the Ministry of education, Ministry of Foreign Affairs, the Department of Immigration and Emigration and the Persons Registration Department have been notified even by now, to accept the Certified Copies issued by the Registrar General without subjecting the Validity period of a certificate to any limit, in accordance with the Provisions of all Acts implemented by the Registrar General. Therefore, you shall take necessary actions to notify the clients come to your office.

03. Accordingly, I kindly inform you to take actions to display, a notice prepared as shown in the back page or another suitable notice, in such a manner that, it can be clearly seen by the Public.

### Special notice to the Public

Copies of the Birth, Marriage and Death Registers, Certified and issued to you by the Registrar General Department, shall not become invalid after a period of 06 months, and shall be valid for any period of time. Since the Ministry of Education, Ministry of Foreign Affairs, the Department of Immigration and Emigration and the Persons Registration Department have been officially informed, I would like to inform you by this, that if you have a clear certified copy issued by the Registrar General Department, there is no need to obtain a new copy again.

Only if any amendments have been done to a Birth, Marriage or Death Register in any case, then a new revised copy shall be submitted.
